Society of St. Vincent de Paul is an international organization that was founded in 1833 in France. It was founded by bl. Frederik Ozanam. The association resumed its activity in Slovakia in 1995 after a break in the historical development /1948.

The activity of the Society of St. Vincent de Paul is committed to helping socially weak families, lonely people, homeless people, former inmates of children's homes, convicts and senior citizens. It is a co-educational facility whose main task is to provide social services to adult natural persons who, due to an unfavorable life situation, are dependent on the help of another natural person. Individual groups of people /5-7 members/ work voluntarily in the Association of St. Vincent in Slovakia and are concentrated under the name "conferences" in accordance with § 62 to 67 of Act 448/2008 Coll. on social services and on the amendment and addition of certain laws, as amended, the association was registered on 31.1.1995 / 20.2.2003 No. . file: VVS/ 1-900/90-10328-1/

The aim of the Society of St. Vincent de Paul is to defend human rights, alleviate poverty and eliminate its causes, which includes charitable service in the broadest and narrowest sense of the word in cooperation with evangelization. The owner acquires rights and obligations independently, in his own name. It can accept financial and material donations for its activities.

2. ESTABLISHMENT AND HISTORY OF THE ASSOCIATION OF ST. VINCENT DE PAUL

Frederik Ozanam (1813 – 1853) university student of law, later university professor of philosophy, law and literature at the Sorbonne, scientist, writer, father of a family, member of the French National Assembly. On April 23, 1833, at Frederik's instigation, six university students of law, medicine, and literature met and founded the Conference of Christian Love, which was later called the Society of St. Vincent de Paul (SVdP). This name is still used by the Society all over the world today.

Young students, that is, already members of the Conference, began to visit the poorest districts of Paris, which was helped by the religious sister **Rozália Rendú**, **Daughter of Christian Charity**, who had a great influence on the charity service. They shared their income, which they received from their parents, it was money, food, clothing and solid fuel. In poor families, children were taught to write, read and were taught their religion. Later, they started visiting barracks and prisons, where spiritual and material help was needed. They founded journeymen's workshops, which produced trained journeymen and masters from the poorest families, who then helped their parents and thus poor families became self-sufficient. Frederik Ozanam was interested in social issues and criticized the political regime in which enrichment was the main goal. He wanted to achieve a division of labor, rest and retirement for the workers.

In 1845, Pope Gregory XVI. /1765 –1846/ approved the organization and its statutes, which Society of St. Vincent de Paul becomes an official work of the Church.

He called individual member communities from 5 to 20 members Ozanam conferences and founded them himself among students and residents. During his lifetime, approximately 100 conferences were established in France and in 16 other countries with over 2,000 members. His movement spread to all countries of Europe and other continents of the world.

Today the Society of St. Vincenta operates on all continents, in 140 countries, has 40,000 conferences, in which 900,000 unpaid lay members work.

Within each country there is a National Council that unites the conferences in that country.

At the head of the world organization of the Society of St. Vincent de Paul is the General Council in Paris.

The first conferences of the Society of St. Vincent on our territory were established within the former Austria-Hungary, specifically in Bratislava in 1867 and later in other cities. Conferences were created at universities. The main activity of students at universities was directed towards the poor, to whom they provided financial and material assistance from their own resources. In 1950, the Society of St. Vincent canceled. The activity of the Society of St. Vincenta was restored in 1991 in Levice. After drafting the statutes of the Society of St. Vincent's civil association was approved by the Ministry of the Interior of the Slovak Republic, the Conference of Bishops of Slovakia and in 1996 by the General Council in Paris. Currently, 123 volunteer members work in 23 conferences in Slovakia, and they focus their activities on the current problems of their surroundings.

The conference is established in cities and towns, and anyone who agrees with its statutes can become a member, man, woman and youth from 15 years of age, regardless of nationality and religion. Individual conferences can be women's, men's, mixed and youth. The conference consisting of 5 to 20 members is headed by the chairman, who convenes and takes care of regular meetings of the members, twice a month, where they pray, talk and plan their activities.

Each conference has its own committee, which is elected by secret ballot for a 5-year period. Committee: chairman / must be a Catholic, according to the Statutes of the General Council in Paris/, vice-chairman, secretary, treasurer and recorder. At the founding meeting of the conference, the members choose an activity according to the needs of the environment, which can change at any time. The founding members choose a patron saint of the conference, for example: St. Helena, Anna, etc. The Association has its Statutes, which the interested party must read and agree to before joining the Association. The person interested in membership fills out the member application twice. One remains for the chairman and the other for the NR SVdP.

Conferences united within one country form a whole, which is called SPOLOK SV. VIN- CENTA DE PAUL (abbreviation SVdP) with the attribute of that country. With us, for example it is SVdP in Slovakia. It is headed by the National Council. In Slovakia, we have a National Council. whose members are representatives of all conferences. They elect a committee consisting of a president, vice president, secretary, treasurer, auditor and manager. A specific country must draw up its statutes - these must be approved by the national Conference of Bishops, and only after that the statutes are approved and accepted into the worldwide SVdP organization by the General Council in Paris.

Within the continents, regions are created mostly according to linguistic and geographical affinity.

There are currently 4 EURO-regions on the European continent. The world organization SVdP is headed by the GENERAL COUNCIL in

Committee of the National Council of the SVdP

The Committee of the NR SVdP has at least 5 members, it is the executive and decision-making body of the NR SVdP.

The members of the Committee of the National Council are elected by the chairpersons of the conferences from the nominated members of the SVdP. The Committee of the National Council elects and dismisses the deputy president of SVdP, vice-presidents of SVdP, secretary, treasurer, auditor from among its members. It meets for negotiations at least 4 times a year. It discusses the recommendations of the international General Council in Paris and applies them to the life of the association. Draws up the SVdP statutes and their amendments, ensures their compliance. Determines the amount of the membership fee every year. Prepares and discusses the annual report, budget and annual financial statements of the association. In accordance with the law, it submits an annual report to the relevant state and church bodies. It proposes and establishes separate social and charitable facilities in accordance with applicable laws.

Members of the NR Committee:

President: The President of the NR is a statutory body that represents the association externally. Convenes and conducts meetings of the VNR, NR and all-Slovak plenary meetings, manages and coordinates the activities of all SVdP bodies on the territory of the Slovak Republic, delegates members to the VNR, prepares an annual report on the activities of the SVdP, which is presented to the NR and the members' meeting of the SVdP, the NR is responsible for its activities SVdP.

Deputy president: Represents the president of the association, helps the president in management activities, is a statutory representative in independent proceedings / may or may not be, it depends on the size of the association./

Vice-President: Ensures the smooth operation of the SVdP in accordance with the applicable statutes, coordinates the cooperation of conferences between itself and NR, assists the President in administrative work and correspondence, ensures the tasks entrusted to him by the President within the region.

Secretary: Ensures all administrative tasks, prepares minutes, ensures connection with conferences, the General Council in Paris, the Conference of Bishops of Slovakia, and other organizations cooperating with SVdP. Maintains central records of conferences and their members in Slovakia

Treasurer: He is responsible for the state of the SVdP cash register, keeps accounting records and records of movable and immovable property. Monitors the accounts of all conferences, carries out a physical inventory of property once a year, reports on its condition, assists in the procurement of property at the request of the president, suggests its disposal, purchase of a new one.

Auditor: Checks the state of management and activities of the SVdP, compliance with the Statutes of the SVdP, conducts random inventory of conference cash registers. Draws attention to shortcomings, suggests solutions for their elimination. The NR SVdP submits a written report on the facts found. He is responsible for his activity to the Members' Meeting of the SVdP.

National Council of SVdP

The National Council is the highest body of the SVdP, composed of members of the NR Committee and presidents of conferences in Slovakia. The National Council elects and dismisses from among its members the deputy president of the SVdP, the vice-presidents of the SVdP.

secretary, treasurer, auditor.

It meets for negotiations at least 4 times a year

It discusses the recommendations of the international General Council in Paris and applies them to the life of conferences.

Approves SVdP statutes and their amendments and ensures their compliance.

It participates in determining the amount of the membership fee every year.

Discusses and approves the annual report, budget and annual financial statements of the association.

In accordance with the law, it recommends submitting an approved annual report to the relevant state and church authorities.

It approves the establishment of separate social and charitable facilities in accordance with applicable laws.

Membership and function in the National Council ceases upon expiration of the term of office, written resignation office, by death, by dismissal from office.

3. ORGANIZATIONAL STRUCTURE, BODIES OF THE ASSOCIATION

Association bodies:

- 1. highest body: membership meeting
- 2. executive body: Committee of the National Council /VNR/, National Council /NR/, whose members are members of the VNR and automatics, all chairpersons of conferences in Slovakia, 3rd statutory bodies:

president of SVdP, deputy president of SVdP

- 4. control body: auditor
- 5. members of the NR SVdP Committee: president, deputy president, two vice-presidents for East and West, secretary, accountant, treasurer, auditor, members delegated by the SVdP president.

The basic organizational unit of SVdP is the so-called **CONFERENCE.** It is an autonomous community that chooses its activity voluntarily and manages it independently. A conference consisting of 5 to 20 members is headed by its chairman. Spiritual guidance by a priest or a responsible individual of the local parish is desirable (not mandatory). Conferences meet 1 to 4 times a month, where they evaluate and plan their activities. NR SVdP is responsible for its activities.

Conference

The conference is a basic organizational component, which consists of a community of members (5 to 20).

ference does not have legal personality. Conferences act as the most diverse charitable associations in the environment where they were established.

Conference Committee

Chairman, secretary, treasurer, possibly another member of the conference.

Conference Committee:

Accepts new conference members.

Manages and directs the charitable activities of the members of the conference.

It monitors the implementation and control of its resolutions.

It ensures the implementation of the resolutions of the National Council.

The position and membership in the conference committee ceases upon expiration of the term of office, written resignation, death, and removal from office.

Working meeting of the conference

Working meetings of conference members are held regularly (e.g. weekly, fortnightly),

it happens with Vincentian spirituality. They serve to transfer experience in charitable activities, solve problems, assign tasks to individual members for the next period, etc.

Chairman of the conference

He calls a membership meeting

Appoints and dismisses the secretary and treasurer of the conference (possibly also another member of the committee) from among its members. He takes care of the equal distribution of responsibility among all members of the conference.

He coordinates the work between members, ensures the coherence and unity of the conference.

In cooperation with all members, he makes sure that the conference is successful.

It ascertains the necessary cooperation of the conference with natural and legal persons who operate in a similar field and is guided by Vincentian spirituality.

He is responsible for his activities to the members' meeting.

Conference Secretary

Ensures administrative tasks, including all initiatives beneficial to its activity.

He writes the minutes of each meeting of the conference, which is also signed by the chairman.

It prepares an annual report on the activities of the conference, which it sends to the National Council of the SVdP.

Treasurer of the conference

He collects the membership fee from the members of the conference.

He keeps records of the management of the conference with financial and other resources and sends them to the SVdP accountant for processing.

Activities of the SVdP National Council in 2022

Society of St. Vincent de Paul in Slovakia organized 23 conferences in 2022, in which 127 members performed unpaid volunteer activities, including 27 men, 20 honorary members and 8 volunteers.

The Committee of the National Assembly of the Association met in the House of Hope in Bratislava:

The program of meetings was focused on the activities of the NR SVdP and individual conferences. At the meetings, current requirements, problems and suggestions for streamlining the activities of the conference, the House of Hope in Bratislava and the Social Center of the shelter and supported housing in Šurany - Kopec were presented. Spiritual development was planned as well as the maintenance and revival of the Vincentian charism in individual conferences.

CONFERENCE OF ST. JOSEF LEVICE

The conference is focused on material and spiritual assistance to socially weak and families with many children as well as individuals and assistance to emigrants from Ukraine. The conference is run by Vincentík with clothing, household items, as needed with durable food and other needs of the needy, sending packages for the poor and needy.

Projects:

FIGHT AGAINST HUNGER - national collection - production and sale of gingerbread hearts GIVE JOY -

Christmas food project - collection of durable food in both churches, supported by approx. 60 families

Activities of conference members -

two members of the Conference of St. Jozefa LV are members of the Committee of the NR SVdP:, one secretary, one press and media coordinator of the association, also the editor-in-chief of the magazine OZANAM and the administrator of the association's website

- one member translation and cooperation with foreign countries /ANJ/ and help with the car
- help to Roma families
- working with the homeless, processing social benefits, processing and financing civil benefits IDs, procurement of clean clothes, medicines and accommodation in facilities

- active cooperation with the Levice-mesto parish office, the Rybníky Regional Office and the city of Levice, the sisters of vinpennies in Levice

Work in Vincentík

- receiving and issuing clothes, school and kitchen supplies, furniture couches, walls, sofas, dressers, wardrobes, washing machines, refrigerators...
- purchase of food, medicines, shoes for families in need during the year
- financial assistance to socially weak families to pay for energy, water...
- year-round sending of packages with clothes and shoes (more than 50 pieces) to needy families in Slovakia preparing bags with clothes for municipalities according to the requirements of social workers for children sending bags with clothes to Romania for Romanian Slovaks to Africa through the Mary's Meals
 organization we provided school bags, bags, large spoons, soaps, toothbrushes, toothpaste and summer sandals for schoolchildren

The conference has 15 members, 8 honorary members, 3 volunteers

CONFERENCE OF ST. JÁNA KRSTITEŸA DUBOVÁ

The conference is run by a local newspaper and a singing group:

- works with young people in the church choir Credo
- are published by Dubovské noviny
- performs charity for the elderly and social. weaker citizens
 The conference has 6 members.

CONFERENCE OF ST. URBANA NITRA

The conference is focused on prayer activity. The conference has 1 member.

CONFERENCE OF ST. LUJZY DE MARILLAC LEFT

The conference takes place at the Catholic United School of St. Vincent de Paul:

- the Fight Against Hunger fundraiser, which took place in Rybníky parish
- Christmas collection: How much love can fit in a shoebox has already become a Christmas tradition. Already
 This is the fifth year the school has participated in this collection. Kindergarten, elementary school and gymnasium prepared in November and in December participated in the collection of towels and washcloths for the organization De Paul Slovakia.
 High school students supported this activity as part of the volunteering week by creating a poster for the school. In October, the

younger students in the religion classes packed boxes full of love for 86 seniors living in a social services home.

- joined the worldwide initiative of the Pontifical Foundation ACN:

 Help for the Suffering Church", which is called "Red Wednesday". On this day, they honored the memory of those who suffered and were persecuted for their religious beliefs, which they supported with prayer, and on this day they were something red.
- during the night they talked about missions and so they became little missionaries for a while.
 The conference has 11 members.

QUEEN'S ROOM JOY CONFERENCE

The activity of the conference consists primarily of regular meetings and the prayer of the holy rosary.

At the meetings, members familiarized themselves with the reports of the NR Association committee and the need to help fellow citizens in their village:

- home visits to elderly lonely people interviews, hearing 55 lonely people
- visits to inmates at the Social Services Center in Radošin 12 times, sent 10 packages

for DSS inmates as Christmas gifts

- visits of children in the newly established children's home 9 times
- hospital visits 2 x
- accommodation of a homeless person with meals for 11 days
- food for a local alcoholic 6 times
- shopping for the sick and those with difficulty in mobility 5x
- Fight against hunger baking and selling gingerbread hearts
- sale of mission calendars and magazines Hlasy help to missions
 The conference has 5 members..

CONFERENCE OF THE HOLY FAMILY KOŠICE - SACA

The conference helps in the parish and meets with the Conference of the Assumption of the Virgin Mary, also in Šac. The conference has 2 members.

CONFERENCE BL. ZEFFERÍNA MALLU KOŠICE – SACA

The conference helps to eliminate the material poverty of the Roma community:

- families in need were given clothes they received from the conference of St. Jozef in Levice
- donated furniture, kitchen appliances and worn clothes went to the poorest families
- they bought food for needy families for Christmas

The conference has 7 members

CONFERENCE OF ST. ANEŽKA BRATISLAVA

The conference helps socially weak families with clothing and financially

CONFERENCE OF THE MIRACULOUS MEDAL OF THE VIRGIN MARY NITRA

The activity of the conference is focused on regular monthly meetings of members, on prayers. At the meetings, they inform about the need to help poor families and individuals. - spiritual assistance to patients (providing the sacraments)

- cleaning the church
- regular financial and food assistance to more than 40 poor families and individuals, assistance through several organizations through the Nitra Diocesan Charity, Bags of St. Vincent of the Vincentian Sisters, Tesco collections,
- grocery shopping for a family with 2 children, learning financial and other literacy (children are also present when shopping)
- provision of fuel for the winter for the poor in cooperation

with the Nitra Family Center, financial assistance to families before Christmas, - assistance in providing public

holidays for the homeless at the House of Charity St. Rafaela - spending time with them when everything is closed and there are cold days, showing valuable religious films and film classics, goodies provided through benefactors in the form of desserts, cakes, soups and other goodies to celebrate the holidays

- every 2 weeks delivery of vegetables (potatoes, carrots, parsley, celery and onions) to the very poor dins and individuals to many municipalities
- help with the import of furniture and clothing, ... -

monetary and material collection for Ukrainians, handed over to the family and to the collection point

- organizing the Fight against Hunger fundraiser
- participation in the SVdP committee: secretary, later after the elections vice-president for the west and one member manages the Facebook profile of the association

The conference has 6 members, 2 honorary members, 3 waiting members and 3 volunteers

CONFERENCE OF ST. ELIZABETH OF HUNGARY BANSKÁ BYSTRICA

The conference was devoted to the following activities:

- prayers for the needs of the association and our members
- church work and accompanying the elderly at St. mass in the Retirement Home
- helping Carmelites prepare lunch and washing church linen in the Church of the Ascension of St. Cross on Calvary

The conference has 4 members

CONFERENCE OF THE VIRGIN MARY OF LOURDES

The conference built and owns the way of the cross, 2 chapels and the park of St. Vincent.

The activity consists of:

- joint meetings with prayer - improvement

of the surroundings of the Way of the Cross, 2 chapels and cleaning of access paths to the cave of St. Jozef ak spring of the Mother of God in Mazáÿek.

The conference has 3 members.

JOHN PAUL II CONFERENCE BRATISLAVA

The conference is devoted to work with youth and evangelization through theater:

-develop the acting talents of children and youth in Ružinov in the field of theater production

they provide space for the presentation of the author's work of young and beginning authors

cooperation with the Marian Youth Association on organizing summer camps for children from socially disadvantaged families

The conference has 4 members.

CONFERENCE OF ST. JUSTÍNA DE JACOBIS ŠURANA

The conference is aimed at helping the Social Center - Útulok Kopec Šurany and former clients, especially in and around Šurany, and poor women, in the following forms:

- baking sweets on the occasion of Christmas, New Year, Easter
- by donating food and clothes, help with shopping and advice in various areas of telephonetically and personally
- helping former clients who have become independent (furniture, household equipment, loans)
- by praying for all SC residents
- helping individuals with cooked food, donated clothes, buying food and household items
- pilgrimages for clients, including former ones, to Pozba, Topoÿÿianok, Nitra for the Cyrilo Methodist pilgrimage
 The conference has 3 members and 2 honorary members.

CONFERENCE OF ST. GORAZDA BRATISLAVA

- monthly the members of the conference pray *the Novena* "Novena" to the Immaculate Virgin Mary "with a request to get new members to SvdP and on the 13th of the month Rosary

8. IMPLEMENTED PROJECTS

Day care center

A grant of EUR 2,070 was obtained from the HMBA for the "Safe Autumn of Life" project for activities: physiotherapy, health style, lectures on Alzheimer's disease, safety of seniors and art therapy.

A project was submitted **to UPSVAR** for activation work for emigrants from Ukraine. From On 15.12.2022, a lady from Ukraine - from Kyiv joined

The General Council of the Association from Paris provided EUR 5,000 for work with Ukrainians. Project was distributed to the needs of Ukrainians in the Association, and also to the needs of the House of Hope.

We received 2,500 from the Bishops' Conference of Slovakia through projects for Ukrainians EUR, for a family living in the House of Hope,

MPSVR financial subsidy for energy according to the number of clients. On the basis of the contract, the Ministry of Internal Affairs and Communications supported the labor costs of the day care center according to the number of clients.

Based on the contract, the Municipal Council of Ružinov supported the day care center with a financial amount.

Social services

In social services during the year, the Conference of St. Gorazda.

Halfway house (DPC) - dormitory

The aim of the half-way home was to provide social care to persons who had completed prescribed institutional care after reaching the age of majority or extended institutional care due to preparation for a profession and did not have secure housing. Due to termination 3-

due to the annual stay of clients of the halfway house social service and the lack of other clients, this service was terminated in June 2020. During 2022, 3 girls from the former halfway house stayed in the House of Hope in the DPC premises, and the vacated room came to live in another new roommate in April. There were no problems with the accommodated girls, cooperation with them was at a good level.

Seat of the National Council and refugees

After the outbreak of the war in Ukraine, refugees from the fighting began to arrive. On March 8, 2022, a family of four came to the House of Hope - refugees from Kharkiv, Ukraine. They were accommodated in 2 rooms on the premises of the 3rd floor, which is available to NR. Grandparents - father, mother, their daughter and granddaughter, a 9-year-old girl. The director of the House of Hope provided them with assistance at the offices, registration in the territory, etc., accompanying them to the doctor and other official requirements. They were immediately provided with material assistance in the form of a collection of food, hygiene, and clothing from the warehouse. At the same time, financial assistance for the most necessary needs. We supported them financially and materially with supplies from the collection from the church, the members also brought clothes and food.

At the time when there were no more collections, we supported them with money, they received approx. 500 EUR for food from the funds that were directly donated to them. The missionary society gave them a donation of EUR 300 for an above-standard tooth repair for their daughter. The General Council provided EUR 5,000 for work with Ukrainians. The project was divided into needs for Ukrainians in the Association, and also for the needs of the House of Hope, the purchase of a new washing machine, vacuum cleaner, cooler, small purchases for Ukrainian refugees. From the Conference of Bishops of Slovakia through projects for Ukrainians, we received EUR 2,500 for the family living in the House of Hope, gradually and approximately EUR 200 per month for food for the child and grandparents. The girl is enrolled in the 4th grade at the United School of St. Vincent. The director of the DON was invited to the performance of the Ukrainian ballet troupe and a banquet, which was also attended by the Prime Minister of the Slovak Republic and the Minister of Foreign Affairs.

During the year, the increased maintenance of the 3rd floor was connected with the use of premises such as oven, toilet, wear and tear of the kitchen, damage to the elevator switch, etc. These problems were solved by the director of the House of Hope. The Ukrainians in the House of Hope spent the big night visiting the Biofarm in Stupava, where they were driven by a volunteer together with the director of the House of Hope, who also gave a gift - canned food, pellets for Felix the cat, the little girl's favorite animal.

Day care center

In 2022, there were 9 clients in the inpatient facility, whose status was alternating: and at the end of the year, 8 clients remained. During 2022, 3 new clients arrived, but 4 left, of which 3 clients went to a facility for the elderly due to old age and 1 client died. A grant of EUR 2,070 was obtained from HMBA for the "Safe autumn of life" project for activities: physiotherapy, health style, lectures on Alzheimer's disease, safety of seniors and art therapy. During the meeting, there was an opportunity to listen to a lecture on the topic of "Treats and safety" together with the clients of the hospital as part of the training for other members of the Association.

The training was carried out by a member of the Police Force of the City of Bratislava II. Exercise aids, reflective tapes, small lamps, canvases for painting, training books, art therapy materials, refreshments during lectures, massage device Beautry Relax 2 pcs., transport trolley for clients, positioning cylinders for exercise were purchased from the grant. There were brain training programs, rehabilitation and massage exercises with a masseuse and a cognitive activity trainer, art therapy with an art therapy lecturer, which also included painting various pictures, lectures from the District Directorate on the topic of safety, lectures on emerging Alzheimer's disease.

The grant from HMBA "Safe Autumn of Life" was successfully completed. There was a promise from the District Directorate of the Police Force that they would train clients in the stationary station for free in 2023, within the framework of the security of Ružinov.

We had good cooperation with 2 volunteers, help in the inpatient unit, religious sister Mária and with our roommate on the 2nd floor, Mr. Martina. Small activities for the development of fine mechanics in stationary were presented in Ozanam magazine. Small client celebrations for birthdays or name days in the hospital always brought a good atmosphere of clients honoring others with a cookie for everyone. According to the regulation of the Ministry of Internal Affairs and Communications, antigen testing was carried out for employees and clients according to the pandemic plan every 7 days. The testing was carried out personally by an employee of the day care center. We are well supplied from VÚC with protective equipment and self-tests in case of Covid.

Members of the day care center participated for the second time during the year in door-to-door visits to the chapel of the Miraculous Medal as well as in the Fasting Box for Africa event, the proceeds of which were sent to SKCH. For the "Fight against hunger" campaign, baked gingerbread hearts were brought to the hospital, the clients wrapped them and handed them over to the nurses for sale. A project was submitted to UPSVAR for activation work for emigrants from Ukraine. From 15.12.2022, a lady from Ukraine - from Kyiv started to help with carrying lunches and cleaning in the hospital as part of the activation work.

An application was submitted to the Ministry of Internal Affairs and Communications for a financial subsidy for energy according to the number of clients, which was also implemented. Ružinov City Council supported the day care center with a certain amount on the basis of the contract. On the basis of the contract, the Ministry of Internal Affairs and Communications also supported the labor costs of the day care center according to the number of clients. In 2022, 1x social service supervision was carried out by prof. doc. Matelo Andrej for Dom nadeje, day care center.

During Lent, a Way of the Cross was regularly held in Mariánka at noon on Saturday under the leadership of Father Jozef Garaj, CM, which was also attended by our members from the Society of St. Vincent de Paul as preparations for Easter.

The SVdP plenary meeting was held on 21 May 2022 in Bratislava at the House of Hope. At the same time they also held elections for the NR SVdP Committee, as the mandate of the previous committee has ended.

The meeting was with the mayor of HMBA Mr. M. Valla on 14.6.2022 and representatives of senior organizations to solve social support for seniors and people with disabilities. Miháliková, director of the House of Hope, attended the meeting on behalf of SVdP.

Fellowship with the Austrian Society of St. Vincent de Paul - Mr. Dietter offered to bring humanitarian aid to Šurany. Since they were also overwhelmed with humanitarian material, they could not accept this help and refused their offer.

On the occasion of 100 years since the foundation of the province of Slávnosti, all branches of the Vincent family took part, M. Boledoviÿová and L. Miháliková represented the Society. On this occasion, each participant was given the book "In the Hand of Providence", which captures a cross-section of the activities of the Vincentian sisters in Slovakia from their arrival through the years of totalitarianism and the current period.

On June 11, 2022, a plenary session of the Life Forum was held in Žilina, fighting for the right to life from conception, the session of which was attended by Libuša Miháliková, director of the House of Hope.

On June 15, 2022, the pilgrimages organized from the church of St. Vincent de Paul in Bratislava. Including some of our members, the pilgrims traveled to Hvozdnice where they prayed at 7 chapels in honor of the Virgin Mary of the Seven Sorrows and the Seven Joys and to nearby Štiavnik, where they visited the church and cemetery where Ján Kuciak, a journalist, was buried.

On October 22, 2022, a nationwide meeting of members of the association was held in Bratislava. P. Milan Grossmann CM handed over the baton of spiritual leadership of the association to Mr. Mykola Dobrov CM from the Missionary Society in Banská Bystrica, who has been working in the association since 1 October 2022. The meeting was led by Libuša Miháliková.

Senior club (KS)

Due to the previous year - the pandemic, the seniors' club collapsed and was not carried out. Seniors had fear of attending joint meetings due to contagion but also loss of mobility due to age.

Cooperation with the Association for Services of Alcoholics Anonymous (AA)

AA's work consists of group - club activities, for which we rent a designated space in the basement. The AA club operated every Tuesday. Cooperation with AA is good, and it was planned since the first projects of DN activity. The contact person for the AA club is Ms. Mayerová.

Other work

During the year, the agenda increased - MPSVR energy subsidies, remuneration subsidies, a new information system for regular entry of clients and employees into the MPSVR system, applications for a grant for facilities for the new year together with SC Šuran, an agenda in connection with Ukrainians staying in accommodation, billing, regular reporting to the Ružinov City Council, etc. With regard to the accommodated persons, it was necessary to supervise them, teach them to save, order the premises, save energy, maintain the building and broken things, the security of the building (turning off lights, mechanical repairs, closing the gate at night, etc.). This work was performed by Libuša Miháliková.

DN maintenance

After 5 years, a revision of the elevator was needed, as well as a revision of the electricity, which was carried out f. KONE and Somat. The gutters on the roof were repaired, the wall after bees was repaired, the kitchen was painted and the lower part of the wall was tiled. The works were financed by a donation from Sr. MUDr. Scheidova. **Repairs** (chairs, blinds on all floors, drilling of picture, mirror, dispenser, couch repair, replacement of springs...) were carried out by the DN director's brother. The repair of the leaking toilet wall was carried out by a maintenance worker called from the emergency service. During the Christmas holidays, the pipes in the basement in the kitchen leaked and at the main water shut-off, the emergency service was called. The repair was paid for by MUDr. Scheidová from the donation to DON, there is still a need to complete the replacement of the oven in the kitchen, which they just reinforced.

In the entire house, except for the meeting room on the 3rd floor, the lights were replaced with more energy-efficient ones. This investment will pay off in energy savings. The meeting room on the third floor will be completed later—after the light fixtures are purchased.

Visit of General President Renát Oliveira from Paris

An extraordinary event was the visit of the Brazilian General President, Mr. Renát Oliveira from Paris, where the conference and the activities of the House of Hope were presented.

The role of the members of the Society of St. Vincent de Paul should not only help people in financial need, but also search and inspire young people who will continue the activities of the Association. This was also one of the main ideas of the president of the General Council of the Association, Renato Lima de Oliveira, who visited Slovakia on December 5 and 6. Adrian Abel, head of the CIAD commission (commission for international cooperation and development) at the General Council of the Association of St. Vincent de Paul.

1. Social center - Shelter

Established for the socially weak: inmates of children's homes, people without shelter and released from prison.

The facility has two accommodation buildings. In the third building, which is leased by the Society from the Šurana Municipal University, there is a kitchen, a dining room, a food store and a chapel.

The shelter provides:

- assistance assistance
- occupational therapy
- resocialization

Assistance is provided by a social worker, helping clients with personal documents, social benefits, job search, UPSVaR records, helping to solve clients' health conditions

Through occupational therapy, the clients participate in the running of the center and, according to their abilities, are assigned to work in the kitchen, in the garden, in the farm yard, on reconstruction work and cleaning. With the help of occupational therapy, work habits are created in clients so that they can adapt to society. By working in the farmyard and in the garden, they obtain agricultural products for their own use.

Meals are prepared in the kitchen according to the client's schedule and under the supervision of a worker. A designated person takes care **of the cleanliness** of personal linen. Clients take care **of hygiene** in accommodation and social spaces according to the schedule.

Resocialization - helps clients, under the supervision of expert assistance through various courses, lectures, to gain hope for a new life.

2. Subsidized housing

In a supported housing facility, social services are provided to a natural person who is dependent on the help of another natural person. The facility serves clients with disabilities.

Supported housing provides:

- year-round accommodation
- social counseling, health services and accompanying to the doctor
- consulting services for solving common problems

Other activities with clients

Individual interviews with clients

Clients often need to talk, tell their feelings, troubles, what is bothering them, or brag about some success, and it suits them better to open up to a person they trust and is close to them, so we are here for them whenever they need it.

Financial advice

In most cases, our clients have a problem with management, and that is why we provide them with financial advice as help and guidance for the future if they become independent.

Community with addicted clients The

social worker organizes a community once a week with clients who are fighting and especially want to fight addiction. They share their weaknesses, their past, and it helps them a lot.

Opekaÿka with clients and St. mass at the pilgrimage site Studniÿka

We have good cooperation with the parish priest Ján Gondek. He usually comes to our facility from-to serve us St. mass. He needed help cleaning the wood at the Studniÿka pilgrimage site, which he takes care of. We were happy to help him. We connected the brigade with St. mass and subsequent roasting.

Barbecue with the sisters from the Vincentian family from Nitra

In the summer, we invited the sisters from Nitra to our facility. We organized St. mass and after mass we also made a barbecue with the sisters. They shared their stories with us, also conducted individual interviews with clients and in general brought spiritual peace and encouragement to our hearts.

Lecture and presentation by Sister Superior about her missionary activities in the Czech Republic and Russia

Sister Superior Damiána Poláková promised us that she would share her experiences and journeys on her missionary journeys. She also showed us footage from these trips in the dining room. The clients listened attentively and it was definitely an enrichment for them and the realization that they are not alone in a difficult situation, and that there are people worse off. It was such an awareness of values for them and appreciating more the things they have.

OPERATING CONDITIONS OF THE PROVISION OF SOCIAL SERVICES

Social welfare is provided in the Šurana Shelter and Supported Housing and the BA Day Clinic service

With a year-round residence permit for a natural person who is dependent on the help of another natural person and their degree of dependence according to Annex no. 3 of Act No. 448/2008 on social services. In the social center Šurany and in the DS in Bratislava we provide:

- 1. help when dependent on the help of another natural person
- 2. social counseling
- 3. social rehabilitation
- 4. accommodation /Šurany/
- 5. catering
- 6. cleaning, washing, ironing and maintenance of linen and clothing in the form of occupational therapy
- 7. personal equipment

11. MANAGEMENT REPORT—COMMENTARY

Society of St. Vincent de Paul in Slovakia /SVdP/

Society of St. Vincent de Paul in Slovakia is a civil association that, through its charitable activities, helps the needy at home and abroad in order to alleviate need and lack and protect human dignity. It is inspired by the spirituality of St. Vincent de Paul.

Members of the Society of St. Vincent de Paul are united in groups called conferences and in social centers - the Šurany Social Center with social services, a shelter and supported housing, and the House of Hope in Bratislava with a day care social service.

For its activities, the organization receives donations, grants, a share of 2%, subsidies from ministries and self-governing regions, fees from clients of social centers. At the same time, she gave a certain part of the premises of the House of Hope for rent.

Thanks to the rental of premises, the Association of St. Vincent's positive economic result of €8161.98.

Activities of the conferences of the Society of St. Vincent de Paul in Slovakia mainly worked with the poor, whom he supported materially and financially even during the pandemic. The material donations provided by the Association mostly consisted of clothing, food, medicine, social assistance in the form of payment for help for children, monetary donations for people in need with verification of their given situation, costs for 1 round of children's summer camp for children from socially deprived families. Conference of St. Jána Krstiteÿa Dubová realized the publication of Dubovské noviny.

To support the activities of the conferences, donations were received from individuals and legal entities, from the Conference of Bishops of Slovakia for exiles, from the Archdiocese BA Charity for work with the needy, a foreign donation from the General Council of Paris to help exiles, and a share of 2% of taxes, a subsidy from Dubová village.

Dom nadeje in Bratislava opened 1 social service, a day care center, where the Municipal Office of subsidies from the Ministry of Social Ružinov, UPSVAR for activation work, received payments, provided Affairs and Health - fees from clients for the social service day care center, a grant from HMBA, donations from individuals and resources from share of 2% for the activities of the House of Hope. To cover the need for total costs, the Association leased a certain part of a house in Bratislava. In March, 2022, he accepted a family of 4 outcasts into the premises of the BA House of Hope, providing them with accommodation, material and financial assistance.

The Surany Social Center opened 2 social services - Shelter and Supported housing for homeless people, where subsidies were provided from the state budget, the Nitra self-governing region - VÚC, MPSVR, fees collected from clients for food and accommodation, activation of own products from the economic yard and rent 1 client.

During the year 2022, supervision of social services was carried out in the Šurany Social Center and House of Hope as a method of constantly increasing the professional competence of workers in helping professions, improving the quality of professional procedures when working with clients, and as a method of increasing the professional competence of workers only in the social center. The quality standards of the conditions of the social services provided are followed as far as possible.

To all members of the Association of St. Vincent de Paul in Slovakia deserves thanks and respect for the work they do without the right to pay, which they do in their spare time. Thanks also go to the workers of the Association of St. Vincent, the Šurana Social Center and the House of Hope, who diligently participate in the improvement of this social work.

12. CONTROL ACTIVITY

Report of the control commission of the Association of St. Vincent de Paul in Slovakia, civil association

On April 12, 2023, an inspection of the activities and management of the civic association Spolku sv. Vincent de Paul in Slovakia for the accounting period of 2022, which ended on December 31, 2022.

The subject of the inspection were accounting documents, accounting books, inventory of assets, liabilities and equity, financial statements for 2022.

The control committee stated: The accounting documents are substantively and formally verified by those responsible persons and accounted for in the accounting books, the financial statements and other analytical records are in accordance with Act no. 431/2002 on accounting, as amended.

Documents proving the use of funds from public sources meet the circumstances in terms of the Act on Financial Control. Documentation in the inventory of assets, liabilities and the difference between assets and liabilities meets the requirements of the Accounting Act.

Expenses incurred in total for the Society of St. Vincent de Paul in Slovakia as of 31.12.2022 were in the amount of EUR 425,423.20, the revenues obtained were in the amount of EUR 434,969.28, the result of the donation is a profit of EUR 9546.08, which after tax is in the amount of EUR 8161.98. The economic result corresponds to reality.

The positive economic result represents the rent from the rented premises of the House of Hope, the apartment at ÿernyševského Street in Bratislava and Social Center Šurany and a small profit from the main activity.

Detailed results for individual activities will be presented in the annual report for 2022.

The Control Commission states that the organization has rightly arrived at a positive **budget** in 2022 to the total farm result of EUR 8161.98, the management is profitable.

The control commission states that the activity of the Association of St. Vincent de Paul and his management of the lo contrary to the statutes of the civil association and recommends approving the economic result.
